Thank you for your participation in the 2018 Cincinnati Mini Maker Faire ("CMMF") at the Hamilton County Fairgrounds (the "Event"). Following is the schedule for the Event:

Friday, September 14<sup>th</sup>, 2018 (Load-in at the Hamilton County Fairgrounds) Saturday, September 15<sup>th</sup>, 2018 (11am-5pm) Sunday, September 16<sup>th</sup>, 2018 (11am-5pm)

As a participant in the Event you are responsible for the following:

- 1. You must pay for all materials, supplies, equipment and other expenses needed to provide your services at the Event.
- 2. You must safeguard your equipment at all times and display materials and agree that Cincinnati Museum Center ("CMC") and the Hamilton County Fairgrounds have no liability for theft or damage to your property occurring while you are at the Hamilton County Fairgrounds for the Event.
- 3. You must exercise reasonable care to prevent personal injury or property damage as a result of your actions or inactions.
- 4. You are responsible for the safe execution of the services you provide in connection with the Event and are liable for any damages caused therefrom.
- 5. You must inform CMC in advance of the Event of any dangerous or hazardous aspects of the services you provide during the Event.
- 6. As an independent contractor, you must assess the amounts and types of insurance coverage needed to adequately cover any potential liability and risk of property damage that you have in connection with your participation in the Event.
- 7. You are assuming liability for any and all individuals and groups associated with the services you are providing during the Event.
- 8. You and your exhibit may appear in recordings of CMMF and related promotional or documentary materials. Your rights are waived to any images and/or recordings you may appear in while at CMMF and any/all related promotional or documentary materials. You acknowledge that CMMF, including the Exhibits, may be recorded in audio, visual, and/or audiovisual media by us and/or our licensees, and you consent to the making and use of such recordings by us and/or our licensees for any purpose, such use including without limitation the transcription, modification, reproduction, public display, distribution, broadcast, and transmission in any form. You release us, and our licensees, from and waive any claims related to or arising by reason of the making and/or use of any such recordings. You grant us, and our licensees, the right to use, in connection with promotion and production of CMMC, your name, likeness, and any trade name and/or logo. The provisions of this paragraph will survive the termination of this agreement.

This Agreement may not be assigned, transferred or changed without the written consent of both you and CMC. This Agreement constitutes the entire agreement between us and supersedes any prior written or verbal agreements between us.
