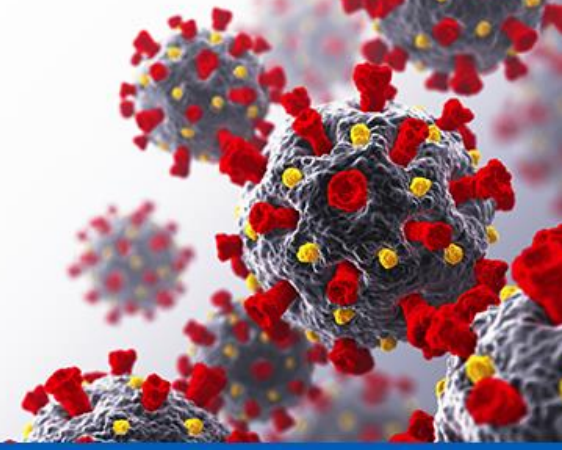


# COVID-19 DAILY UPDATE

## LAW ENFORCEMENT PRESENCE ON HOSPITAL CAMPUSES:

- Governor Beshear asked law enforcement and the National Guard in the state to have a presence at hospitals across the Commonwealth, in preparation for getting busier in the coming days. Beginning this afternoon, Kentucky State troopers and other local law enforcement officers will be stationed near our Emergency Departments.

## VIDEO VISITS:

- Amid all of the chaos, we thought you'd appreciate something to celebrate. In the entire month of February, SEP providers conducted 20 video visits. This promising new service to patients, which has been planned for months, was suddenly launched into action last week as a key strategy to reduce exposure risk of patients coming into the practices. Last Thursday, we conducted 700 video visits in one day, and on Monday completed more than 1,500. Since last Monday St. Elizabeth has performed nearly 5,300 video visits! You should know this far exceeds even much larger healthcare systems in the country and is proof that great things can be accomplished when wonderful people come together in times of need! #STEproud

## DAYCARE OPTIONS THROUGH MAY 31, 2020:

- Several NKY daycare centers have applied to the state to transition to serving healthcare workers and first responders only, per the exception allowed by Kentucky.
- The **YMCA** is currently approved and has a capacity across the Greater Cincinnati YMCAs for 1,100 children.

- **Learning Grove** has also been approved by the state and will offer two childcare facilities for healthcare and emergency personnel. (Please see attachment.)
  - Will serve children, infant through school age (up to age 12).
  - Cost of \$200 a week per child. Full time spaces only.
